NMLA Archives and Archivists SIG Annual Report October 1, 2024

Since the last joint meeting of the Archives & Archivists SIG and the NALSIG on October 26, 2023, the following activities have occurred.

Regular Meetings

We held five meetings with our SIG membership and documented the associated meeting minutes:

Professional Development

The SIG hosted two Society of American Archivists (SAA) webcasts, one ArchivesSpace virtual training session, one live speaker Zoom session, and one professional journal article reading. All activities were held on Zoom and were followed by group discussion:

Budget

• The budget request for \$1,700 was approved by the NMLA Executive Board. The budget will cover professional development activities (webcasts, live speakers, training workshops) as well as the purchase of outreach and promotional items to be used at in-person events.

SIG Leadership

Abbie Olivas and Ada Negraru are in their second year as co-chairs of the SIG. Jonathan Pringle stepped down as SIG webmaster and Ada Negraru has taken over. Regina Bouley Sweetin stepped down as Secretary and Donna Wojcik is now in that position.

Other Activities

- A survey questionnaire was sent to the SIG members to be used in the selection of professional development webinars and other activities during FY 2025. 31 responses were recorded.
- Pieces about the Archives & Archivists SIG were submitted for publication in the November/ December 2023, January/ February, March/April, May/June, July/ August, and September/ October issues of the NMLA Newsletter.
- Ada Negraru and Abbie Olivas organized an archival consultation table at the Historical Society of New Mexico Annual Conference, Albuquerque, NM, on April 26. 2024.
- Abbie Olivas presented (with Deborah Rhue, Librarian at HSLIC) Global Health Problems in New Mexico: Resources in HSLIC Special Collections on June 6, 2024.
- Abbie Olivas and Ada Negraru's article "NMLA's Archives & Archivists Special Interest Group" was published in the Southwestern Archivist vol. 47, issue 3 (August, 2024).
- Brittany Garcia developed the NM Emergency Aid questionnaire and information sheet, a resource sharing tool that archives can use in case of forest fires, floods and other disasters: NM Archives Emergency Aid (google.com)
- Abbie Olivas submitted an application for the Society of Southwest Archivists Community Outreach Fund with the goal to obtain additional funds to support two Archives Bazaar events; each bazaar was awarded \$400.
- The SIG discussed having a meeting dedicated to discussing statewide metadata standards and initiatives for archives. This meeting is tentatively set for November 2024.
- Two Archives Bazaar events are scheduled to occur during Archives Month:
 Border Archives Bazaar at the NM Heritage Farm & Ranch Museum, Las Cruces,
 on October 19; and the Archives Bazaar / "Bizarre" at Meow Wolf, Santa Fe, on
 October 28, 2024.
- The listserv currently has 118 subscribers.
